## Evaluation Methods Used:

Automated accessibility testing was conducted using Deque Axe DevTools browser extension in Chrome, and axe core CLI page scans (specifically full-page scan, partial page scan, intelligent guided test, and user flow scan) to identify and correct accessibility issues within the Help Center interface. Manual accessibility testing was conducted on several critical pages, which included:

- **Keyboard navigation:** Ensure that all functionalities are accessible via the keyboard.
- **Accessibility tree investigation:** Ensure every interactable element has an accessible name, role, and state using Axe DevTools browser extension and Intelligent Guided Tests (IGTs).
- **Screen reader testing:** Verify that content is properly announced by screen readers.
- **Visual presentation:** Check for issues related to color contrast, text resizing, and layout using browser devtools and color-contrast checker.
